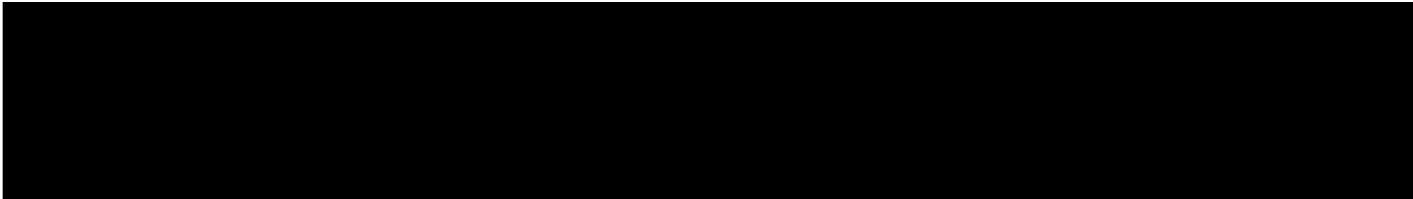
Homeland Security Interrogation of Kevin Vasquez (KV) - 07/20/12

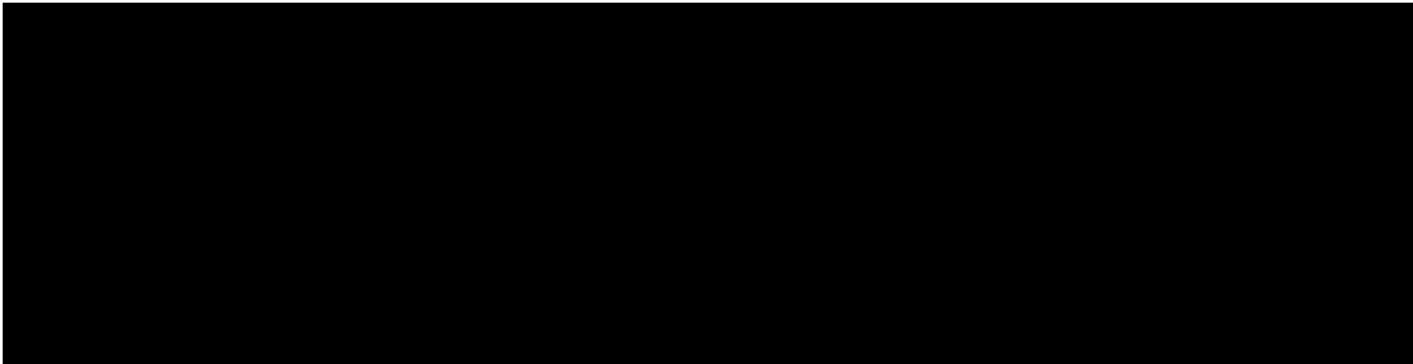
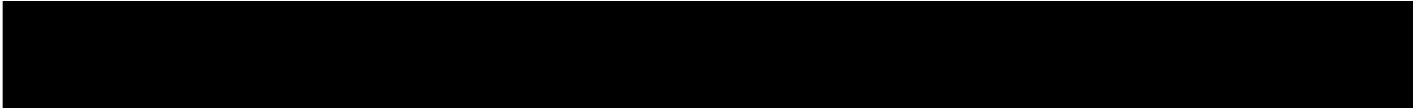
Viewing & Documenting Video

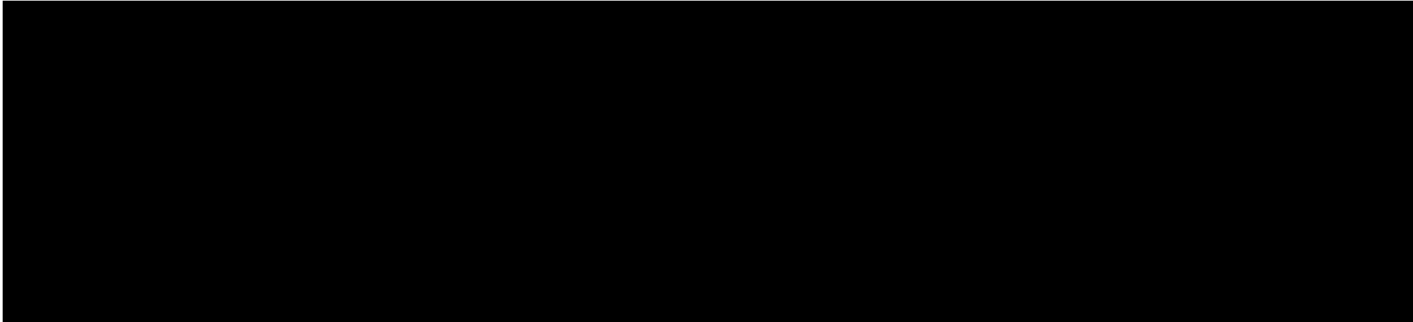


- KV had a cognitive understanding of what the truth & a lie is, giving examples.
- KV was not fidgeting during the interview, but he was not comfortable b/c he was nervous about being recorded, and did not know if he was in trouble or not. His biggest concern was his mom seeing the video.
- KV stated he liked adults, like talking to them, they were interesting.
- KV reasoning for going to the UK matches Jason Gandy's (JG) statement: that JG's mom was from there; KV really wanted to go b/c of a band, a clothing store & the Olympics.
- KV seems to easily make enemies w/friends his age.
- The interviewer repeated already answered questions by KV; his second set of answers were the same.
- KV liked to hang out @ JG's house b/c it was cool feeding his fish, talking to his renters, playing w/his renters' cats & dogs, helping JG build things, & helping JG w/his phone calls b/c he messes up by not calling back. (JG's statement confirmed this as well.)
- KV admitted JG didn't give him any money other than paying for his ticket to the UK, which was \$900. This amount is important b/c it is the same amount that KV indicated he earned from JG for doing massages.
- JG knew KV was 15, but KV did not initially know how old JG was.
- KV didn't want to cause trouble for JG; he was worried JG would not call him again after everything that has happened.

Tuesday, June 30, 2015

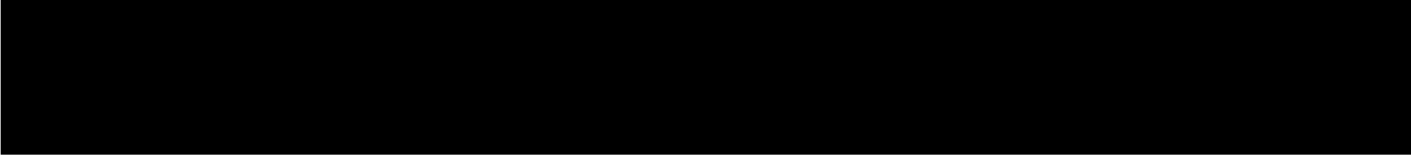
- During the first break KV looks tired as he continued to put his head down and appeared to be nodding off. He laid his head down on his arm, yawned, popped his back. When the HS interviewer returned, KV told her he was very sleepy.
 - HS asked why KV was lying about the massages he was part of; KV said he didn't lie, but that the interviewer didn't ask about it. Before he would agree to even talk about it, KV asked if his family would see the video b/c he was afraid of what they might do or him losing his privileges.

- KV knows JG would never hurt him, would always take care of him, would never lay a hand on him, and further stated he NEVER touched him.

- When KV stayed @ JG's house, he slept in the RV in the garage b/c it's more comfortable & he has access to the internet; JG sleeps in the studio.

- KV never elaborated on issues unless specifically asked.

Tuesday, June 30, 2015

- 
- KV takes all the credit for making the UK trip happen, and he wanted to stay for a month.
 - KV thought JG was mad at him when they were taken into custody in the UK b/c they were separated. KV knew he was in a lot of trouble @ that time. KV was most concerned about getting in trouble for talking to the authorities. No one ever told him not to talk about anything, nor told him not to talk about the massages.
 - JG never spoke about the massages being illegal, but KV knew it was something he should not speak about if he still wanted to make money.
 - KV was concerned for how long they would make him talk; like if they didn't everything they wanted to hear, would they make him talk longer until they heard what they wanted? KV didn't understand why they had to talk about everything so long b/c he had already said everything.

At approximately 2-½ hours into the interrogation, the interviewer offered KV water & the use of the bathroom; he accepted. After returning from the break, the interviewer reiterated much of the same info, as if to check & see if the facts were answered the



- KV added that his mother let him go b/c it was his dream & she didn't want to hurt his feelings. She also knew I know how to take care of myself, she knows I'm always ok, I can find my way through whatever; my mom fully trusts me. She told JG to take care of him, and KV KNEW JG would take care of him; he is someone he can highly trust; he's never done anything to me, not even make me mad; JG is as nice as can be. He knows I know everything about him and can report him if I need to.
- KV was concerned that b/c he has known too much for so long, could he get in trouble later; like what if someone sees the video later, he was scared about that and asked again if he was still being recorded.

Tuesday, June 30, 2015

The interviewer told KV not to worry about getting in trouble & eluded to only adults can get in trouble for these things. She asked if KV has any questions, he wanted to know the following:

- Where was JG?
- Is JG in the building?
- What's gonna happen to JG.
- Do I have to go to the doctor after this?
- Will I be informed what is gonna happen after all this is over. (Was concerned about JG; he is his friend & likes talking to him; doesn't want to get him in trouble.)
- Do I get my stuff back (phone/camera)?
- Do I ever have to see these officials again?
